

A Career at St Edmund's College Apprentice Groundsperson Job Description Head of Grounds Reporting to: **Probationary Period:** 6 Months This is a full-time post whilst offering funding for the successful candidate to work towards the Level 2 Sports Turf Operative qualification. Hours normally 8.00am – 4.30pm, which includes a 30-minute, unpaid lunch break. During term time, a free Hours: lunch is available in the Refectory, and you are also entitled to two paid, 15-minute breaks within the working day. You may be required to work an occasional evening or part of a weekend on College events. The grounds of the college consist of 440 acres, comprising parkland, sports facilities and farmland, the Grounds Department are responsible for approximately 110 acres Summary: of this. Grounds near to the main buildings require regular maintenance. Maintaining the college grounds and sports facilities, to the highest standard. Safe use and operation of machinery and equipment. Maintenance of equipment and reporting faults. Reporting accidents and incidents, to the Head of Grounds. Attending organised training. Grass cutting in all areas. Garden clearance. Occasional grounds projects. Weed killing and treatment of grassed and hard areas. Upkeep of plants in garden areas. Fence maintenance and installation. Path maintenance and installation. Main Duties and Car park maintenance. Responsibilities: Conservation work and low-level tree surgery. Sports pitch maintenance. Sweep and maintain synthetic pitches. Prepare and maintain cricket squares. Precautionary salting and snow clearing. preparing for College Sports Days and main events. Undertaking other duties of an appropriate level and nature as and when requested by the Head of Grounds. To work safely and operate within health & safety regulations at all times whilst complying with manual handling guidance. To have due regard for safeguarding and promoting the welfare of children and young people and to follow the child protection procedures detailed in the College's code of conduct. Whilst not in a teaching role, as an Apprentice Groundsperson you will be working Safeguarding on a regular basis in a school in a role which gives opportunity for contact with Responsibilities: children. As such, you will be in regulated activity and an enhanced DBS check





	(which includes children's barred list information) will be required in advance of appointment.
